- There are no residents present, but there were many complaints about the snowplowing
- Glenn said they are instructed to plow Brennan and Baleena and to keep the other roads as best
 as possible, which means that they plow 1 pass per street until the snow has stopped and then
 the must plow curb to curb. Normally they have 3 trucks, but this last storm they only had 2
 trucks and then 1 of those trucks broke, so they were down to only 1 truck for some of the
 storm
- Glenn had a long discussion with Jeff and Jeff said that after 20 inches of snow, they could have brought in a front end loader to remove the remaining snow, which would have cost more
- We pay for snow plowing by the hour
- During the storm there were many cars parked on the street, which makes snow removal difficult. Brennan and Ballina were relatively clear, but the other streets were not so great.
- The newsletter will go out in a few days and we will include something about asking the residents to park in driveways in the event of snow which will help with snow removal.

Heather calls meeting to order at 7:10

Bethany Hall Long, Our State Senator is here and would like to say a few words:

- Brennan is a great community to work with
- If there is anything that she can help with, please call her
- They have been very busy in Dover. It will be another fiscally challenging year and they will be looking to make some cuts to the budget, but they will not be cutting the reimbursement for snowplowing
- She has to leave early tonight to go to two other neighborhoods that did not get plowed at all because they have no homeowners association
- The workforce housing application has expired for Frazer Road, but they could submit another application
- She will come back again when the plans have been finalized for the traffic calming project
- Penny feels that part of the problem is the school and the lack of adequate parking. She doesn't think the road is really the problem
- Bethany said that the dialogue is still continuing and there is still time to revisit the calming of the boulevard

Questions/Comments from the residents about the snow

- Jerry Stanton of the Southwoods commented that they did a great job with the snow removal
- Heather said that the crews worked for 48 hours straight and even used a front end loader
- Kathryn Chandler asked why a front end loader came in after the storm ended and was it a
 necessary expense? Heather responded that they wanted to stay ahead of the snow that was
 coming later in the week and we will be reimbursed a portion of the money by the state
- Another resident was concerned that the snow removal damaged the grass. Heather responded that the grass will be replaced by Altra at their expense.
- Toni said that the front end loaders were brought in to help near the townhouses where people
 park in the street and they were also used at the crossroads because the big snow piles blocked
 the visibility
- The majority of the complaints about the plowing were regarding the plows only making 1 pass down the road. They make that original pass during the storm so that an emergency vehicle could get down the street if it was needed. Then, after the storm is over, they go back and clean up the rest of the snow.
- A resident, who was a former firefighter, has concerns about the fire hydrants being blocked.
 Penny responded that this is something we should look at for the future so that snow does not get piled on top of the hydrant.
- Heather asked his opinion as to how this could be handled. He said that they sell a fiberglass pole that reaches 4 feet tall and there is a flag on it to mark the hydrant or you could put a dot on the road marking the spot where the hydrant is.
- As it turns out, the fire department has a map of the development with the hydrants marked on it.
- A resident said that 3 snowplows came by his house when the road did not even need to be plowed. There was less than 1 inch of snow on the ground. He wants to know if we can question the company when they present the bill since they charge by the hour? Penny said that some of the plows were in the neighborhood plowing driveways.
- Toni said that this is the worst storm we have had. Last year we paid \$14000 and it hardly snowed this year it should be double
- The resident wants to know why we pay by the hour instead of by the inch since Deldot's calculations are low and the state won't pay the entire amount? Heather responds that the higher the snowfall the higher the reimbursement. Gerri said that Deldot reimburses by inches measured at the airport and Heather said that it is cheaper to pay by the hour instead of by the inch.
- Penny said that she went through several neighborhoods nearby to compare the snow removal and said that Brennan looked just as good.
- Nemishh said that the Brennan Blvd sidewalks will be done, they are coming back tomorrow.
 The sidewalks in front the houses are the responsibility of the homeowner and need to be cleared by the homeowner.

• Penny asked if the school would help to pay the cost of the snow removal on the sidewalk. Heather said that the sidewalk is considered the common area of Brennan and we are responsible.

Questions of the Budget

- What are gen admin expenses? This money is used to pay someone to answer the phones, monitor the email, send out correspondence, we bought 2 computers that are Brennan property. There is also computer training and a post office box
- The county is charging \$6 per house and this fee is mandatory. If we don't pay, they won't send out the bills for the annual dues. It would cost us a lot more than \$6 per home if we did this ourselves. They send out the mail and even 3 follow up bills if necessary. They also track all the payments and pay for the envelopes and stamps. Gerri thinks \$6 is a good price considering the man hours involved in 828 homes. If someone does not pay their dues, we still pay the \$6.
- There is a question about last years dues. We are doing well at recouping the money. If they don't pay, the lawyer puts a lien on the house and we get the money back eventually
- When will the invoices be sent out? If the budget is approved tonight, it will be registered with the county tomorrow and the invoices should go out within the next 3 weeks.
- If the budget passes the dues will increase by \$13, to \$230 per house per year.
- Do we pay the dues all at once? Yes
- Why are the legal fees so high, but we spent so little last year? In 2008 there were a lot of legal fees, in 2009 there were not so many. This year may be high again because many people didn't pay their dues for 2009 and we are also paying an attorney for deed restriction violations. We budget a lot, but we hope to use less than that
- There is a line item under grounds, what did we do to storm water? We discovered a pond that we never knew was there and we had a 1 time clean up
- Question about the trees and shrubs? Applied with the county for matching funds for tree removal, but this is not for planting this year. We will spend \$3000-\$4,000 for tree removal.
- Penny wants to address the vandalism. If you see vandalism, please report it to 911. We hope to light up more areas to prevent it. A resident asked if we go after someone if we know that they vandalized something? Yes, if we catch them we will prosecute and try to get some of the money back
