### 2011 BUDGET

DISCUSSION	GM + GT met with Mike Hard and adj. made to audit budget. Ron Derr will do audit.	
STORM WATER MANAGEMENT		
DISCUSSION	Actual is higher than budget because of repeat pump failure. Pumps removed to prevent further failure (\$500 to remove and \$500 to reinstall.) RS suggest whether repairs should be done again. Failures are due to residents fishing and using the ponds inappropriately. GM states that indeed some areas are not ponds but Wetlands and will must abide by county regs as not community owned. GT to check with County and see if we can stay in compliance and treat bi-annually.HM recommends we use chicken wire/netting to cover pumps and prevent further damage. Nearly all "NO FISHING" signs have been removed. PW suggests anchoring signs in middle of pond like a buoy.	
CONCLUSIONS	GM suggests reordering new signs as posts still exist. GM believes Storm Water Mgnt will remain on budget this year.	

PLAYGROUNDS	GLENN MATTHEW
DISCUSSION	Bullet slider monkey bars have been removed because of damage. HM has inspected and believes that playgrounds may last another 2 years. At Castle playground rockers will need to be replaced – but suggests not replacing them to alleviate

	further damage in future. Not much vandalism reported this year perhaps because of inclement weather or no repairs done.

DISCUSSION	PW suggests a Q & A section of newsletter explaining some of the higher actuals in the budget and also to include safety reminders re: ponds.

CNOW DEMOVAL	CLENI MATTHEW
DISCUSSION	GLEN MATTHEW  GM suggests a separate acct for snow removal so that what is unused in 2011 will roll into 2012 to allow for larger snow removal bills in bad weather years. HM concerned as to why sidewalks were not plowed, GM believed the snow was not deep enough (< 4"). 2011 BUDGET	HEATHER MCVEY
	States that we are actively pursuing liens. Assessments will be out in March. The County does the billing and acceptance of payments with a 30 day payment term.  Question as to how many outstanding payments?  Gerri Thomas states approx. 49. We need to budget \$5,000 because of attorney fees. At last statement \$69,000 was owed
DISCUSSION	to Brennan Estates Association. This is the biggest push for dues to date. Last year, the Association was more lenient on residents, but this year they are pushing for better results. VANDALISM:  B E only spent \$4000 on repairs because of weather delay. Still searching for suspects. One Resident who took pictures of vandals did not want to press charges. Please call 911 if you

	see any acts of vandalism. Talk to your neighbors. STORM WATER MANAGEMENT: Recurring Maintenance charges, pumps and chemicals. Please remember no fishing, skating, wading in the ponds. Gerri Thomas to investigate whether we can treat the ponds only twice a year instead of three to try and reduce our costs. LAWN MOWING: Question: Does it include open space in Southwoods? Nemishh Mehta states that it should be included. Complaint from resident about trash located in open space on Dunleary Drive – trash has been there since December 2010. Resident states a lot of debris in trees and scattered everywhere. Dan McVey thanks resident for bringing it to the Board's attention
	and reminds the Resident about the email and voicemail line and will contact our clean up crew to try and clean up this area.

EXPLANATION OF PROGRESS IN COMMUNITY	HEATHER MCVEY
DISCUSSION	PONDS: Replaced pumps in several ponds – as a reminder these ponds are not to be used for any recreational activities. TENNIS COURTS: Re-surfaced tennis courts, new nets and new drainage with a cost of \$75000 LANDSCAPING: New plants and some irrigation PLAYGROUNDS: There is new equipment needed FINANCIAL REPORT: No Financial report to give at this time as we are mid month. Any resident who would like more information should contact Gerri Thomas. Question about traffic calming proposal on Brennan Blvd.: Vote did not get approved by County, so back to the planning stage, and perhaps just in front of Olive B. Loss. Complaints from Residents about school drop off vehicles parking too close to stop signs. State troopers will increase traffic patrols for this.
CRIME & TRAFFIC	SENIOR CORPORAL JAMES GLADNEY
DISCUSSION	TRAFFIC: Traffic is the #1 complaint nationwide and the police have been conducting Radar patrols on Ballina & Brennan Blvds. Tickets have been issued for parking on sidewalks. INCIDENTS: Nov 2010-February 2011 – 71 calls to the police but no burglaries to residences or sheds. Historically this is a quiet time for crime because of the weather and kids in school. Brennan Estates is very lucky as a result of the downturn of the economy, Lots of other communities are getting hit. Burglaries are increasing with the price of gold increase. Always call in any suspicious activities. Lock your car doors, with no valuables inside – EVEN IN YOUR OWN GARAGE. SURVEILLANCE CAMERAS: Brennan Estates Association looking into getting surveillance cameras at playgrounds and police will follow up on any complaints. Cameras would be at tennis courts and playground, Heather states that this is still under discussion with the board, would be wireless cameras but no place to situate the other equipment. Prelim estimate is \$30,000 and the Board is in favor of having surveillance. Penny adds that the Board decided to only clean the graffiti once a

MAINTENANCE OF FORECLOSURES	GLENN MATTHEWS
DISCUSSION	Brennan Estates has been cutting the grass of all foreclosed properties in order to maintain a good appearance. We have been unable to recoup this money back from the mortgage companies and with more foreclosed properties we cannot sustain this service.
CONCLUSIONS	Suggested that we should complain to the county and let the individual neighbors handle this.

FOUNTAINS	HEATHER MCVEY
DISCUSSION	Fountains should start operating again shortly, delayed because of weather. Some lights are non operational presently because of a missing part that is on order.
SNOW REMOVAL	GLENN MATTHEWS
DISCUSSION	\$28,885 has been paid out for snow removal. A portion of this will be reimbursed by the county for Brennan Blvd. Not sure if they will reimburse for salt costs. State won't reimburse for all sidewalks – we have to clear one sidewalk for access to Olive B Loss school.
WEBSITE	JIM HANSEN
DISCUSSION	Residents will only receive one newsletter per year – hoping to do everything else electronically. Website is a work in progress and some suggestions have been put forward to enhance it. Addresses of delinquent properties will be listed on the website – not the amount owed - just the address.
CONCLUSSIONS	New website is operational as of April 13 <sup>th</sup> 2011.

MAINTENANCE OF COMMON AREAS	HEATHER MCVEY
DISCUSSION	New gazebo doors have been installed at the front entrance – previous Bilco doors had rotted. This time the doors are galvanized steel so should last longer – cost \$1400 installed.  Mulching – Approved to be done every year – scheduled for May 2011. Dan mentions a new Federal law passed to give better access to handicapped persons to all playgrounds – suggesting one must use a synthetic mulch to facilitate wheelchair access. We don't have a cost for that – but it should last longer.  New trees – Meadows – In Primrose Circle – trees will be replaced – delay because of weather.  Storm Water Ponds – have been reworked – now have drainage tubs in the middle to help water dissipate into the ground faster. NCC paid for all of this not BE.  Brickwork at front of neighborhood – this needs to be power washed. Glenn will call H20 under pressure, motion approved by Dan and 2 <sup>nd</sup> by Heather – motion carries.  No fishing signs – we still want to get more signs – but need to figure out a way to install them without being stolen.
CONCLUSIONS	

MAILBOXES – WOODS & TERRACES	
DISCUSSION	Signs posted at cluster mailboxes – NO PARKING. Any vehicles blocking these boxes prevents mail delivery. Any vehicles parked will be ticketed.

SIDEWALKS	GLENN MATTHEWS
DISCUSSION	As a reminder – the sidewalk in front or at the side of your house is your responsibility. The grass needs to be edged or the concrete will break down. The sidewalks are starting to fail along Ballina Blvd. Glenn will get estimates.
CONCLUSIONS	Please advise the Board if you are aware of any other failing sidewalks.

DEED RESTRICTIONS	GLENN MATTHEWS
DISCUSSION	Concern from homeowners that homeowners are not abiding by the deed restrictions when getting a new roof. BE cannot control which manufacturer of shingles a homeowner chooses to use for their new roof or the color of the shingles.  Glenn also raises concerns about trash cans left outside houses for the entire week which is in breach of deed restrictions.
CONCLUSIONS	We will remind homeowners that any home improvements should try and match as much as possible.
